**Subject: Issuance of Exempted FASTags to Hon'ble Judges, as defined in the under National Highways Fee Rules, 2008 -reg**

Sir,

It has come to notice that unpleasant incidents have occurred with Hon'ble Judges at Toll Plaza. It is humbly submitted that Rule 11 of prevailing NH Fee Rules, 2008 provide for exemption from payment of user fee for certain categories of vehicle. As per Rule 11 of the said Rules, no fee shall be levied or collected from a mechanical vehicle [and a security vehicle], transporting and accompanying-

- (v) the Chief Justice of India;*
- (ix) the Judge of the Supreme Court;*
- (xv) the Chief Justice of a High Court;*
- (xvi) the Judge of a High Court*

2. Accordingly, eligible vehicles may apply for exempted FASTags as per the Ministry's Standard Operating Procedure (SOP) dated 9<sup>th</sup> November, 2019, through the Exempted FASTag Portal <https://exemptedfastag.nhai.org/Exemptedfastag/>. The process for obtaining the exempted FASTag is specified by the Standard Operating Procedure (SOP) issued by this Ministry's letter no. H-25016/02/2018-Toll dated 9<sup>th</sup> November, 2019 (Copy enclosed).

3. In pursuance to the above, it is kindly requested to avail the facility of exempted FASTag as provisioned under National Highways Fee (Determination of Rates and Collection) Rules, 2008. This measure will help ensure smooth passage, minimize human interaction, and remove any inconvenience to the Hon'ble Judges while traveling on National Highways.
