OFFICE MEMORANDUM

Subject: Streamlining of processing of applications for grant of Access Permission and Right of Way (RoW) permissions through revamped *Rajmarg Pravesh* Portal - reg.

The undersigned is directed to state that the Ministry has revamped the existing portal for grant of No Objection Certificates (NOCs) for Access Permission and Right of Way (RoW) permissions for accommodation of public and industrial utilities under the provisions of the Control of National Highways (Land and Traffic) Act, 2002.

2. The revamped portal, namely *Rajmarg Pravesh*, was launched on **25.02.2026** and has been developed as a fully digital and paperless platform for end-to-end processing of applications, including submission of site inspection reports and execution of agreements. The portal is operational, and all applications are required to be processed exclusively through this platform. However, it has been observed that in certain instances, field offices are continuing to insist upon submission of physical documents and hard copies of applications, which is not in consonance with the digital framework of the portal.

3. In view of the above, the following instructions are issued for strict compliance by all field officers of Implementing Agencies and Authorised Officers of Highway Administration:

i. **Mandatory Use of Portal and Mobile applications for inspection:**

With the launch of the revamped portal, the earlier system for submission of applications has been discontinued. All new applications shall mandatorily be submitted and processed through the *Rajmarg Pravesh* portal only. Further, a facility for onboarding and migration of applications submitted through the earlier version of the portal shall be made available shortly, which will be notified separately on the Ministry's website. Further, all the inspection reports shall be submitted by AE/IE/Representative of proposing authority through *Rajmarg Pravesh* Mobile application, which can be downloaded from Play Store.

ii. **Digital Execution of Licence Agreements:**

It is hereby clarified that submission or uploading of physically signed licence deeds is not required. The licence agreements for Access Permission and RoW permissions have been duly digitised and shall be executed through legally valid digital mode by the applicant and the Authorised Officer of the Highway Administration.

iii. **Acceptance of e-Bank Guarantees:**

In furtherance of complete digitisation, only e-Bank Guarantees shall be accepted for all purposes under the said permissions. Submission of Bank Guarantees in physical form shall not be entertained.

iv. **Jurisdictional Mapping and Transfer of Applications:**

The jurisdictional mapping of National Highways has been configured based on data available from the RAMS portal. In cases where an application is received by an

authority not having jurisdiction or having incomplete jurisdiction, the same shall be promptly transferred to the concerned field officer or the Nodal Officer of the Implementing Agency without delay.

v. **Special Provision for BharatNet Projects:**

The portal has been configured to incorporate special timelines for disposal of applications pertaining to BharatNet projects, which are required to be processed within a period of 7 days. Failure to adhere to the stipulated timeline shall result in deemed approval, and such delays shall be flagged to the concerned Nodal Officers of Highway Administration.

vi. **Access to Portal and Registration Support:**

All concerned officers shall access the Rajmarg Pravesh portal using their existing credentials of the Data Lake portal.

vii. For facilitating bulk registration and seamless onboarding, Regional Officers shall furnish details of all Proposing Authorities and Competent Authorities in the prescribed format to: **support-rmp@gov.in**.

For any technical issues including any other issues related to processing of the applications and suggestions, the above email may also be referred.
